### Update 2:

Last week my supervisor shared that a client had received a notice requesting medical evidence in their application for adjustment of status. This notice was great news because the request for the results of a medical evaluation is one step closer for the client to have their application for permanent residence reviewed. Our next step was to gather information about the approved civil surgeons' requirements and find ones who perform the immigration medical examination at an affordable price near our client's home or workspace for their convenience. I took the lead in conducting this research and created a chart with the information later shared with the client. In addition to the work for this client, I am conducting supplemental research concerning the country conditions in South America to build evidence for a client seeking asylum. I am reviewing country reports on human rights practices from NGO's international organizations, newspapers, periodicals, and various websites.
