Dear Mr. Ruben,

I am writing to express my deepest gratitude to you and to Equal Justice America for funding my summer work with Atlanta Legal Aid Society (ALAS). With your support I was able to provide direct legal assistance to a number of low income individuals while working alongside some of the finest legal services attorneys in the country. This experience solidified my commitment to public interest work and would not have been possible without EJA's support.

This summer I worked in ALAS's General Law Unit. This unit primarily handles housing, consumer, and public benefits cases. From my first day with the unit I was struck by the passion and energy with which the attorneys and staff approached their cases. Their dedication to the clients and to the legal services mission served as a constant inspiration throughout my time with ALAS.

Though I was able to work with many clients this summer, my experience with one stands out as especially impactful. This particular client was a middle aged woman facing eviction from her subsidized housing complex for nonpayment of rent. Although the client had attempted to explain that her missed payment was due to a costly family hardship, she was ignored by her landlord and served with an eviction complaint. When the client came to ALAS and showed us the complaint we noticed that the landlord had hired an eviction services company to prepare and file it with the court. We also noticed that the landlord had included some hidden fees in the costs it was asking our client to pay. Both of these practices are illegal under state law, but rarely caught by tenants.

At our client's court hearing I was able to negotiate with the landlord's attorney and secured a consent agreement that allowed our client to keep her apartment for the small cost of a late fee, hundreds of dollars less than the landlord had demanded from her. A few weeks later, I referred our client to a private attorney who was in the process of identifying potential plaintiffs for a class action suit against the company that had filed the eviction complaint in our client's case.

Handling this case gave me invaluable insight into the unfair and deceptive practices that plague low income tenants in major cities. Without the help of ALAS it is likely that our client, who did not have the money her landlord was demanding, would have been evicted and possibly become homeless. Meanwhile, her landlord would have profited from a high volume eviction practice that illegally employs contractors to serve complaints on often unsuspecting tenants. This experience reinforced my belief in the power of aggressive legal services attorneys and their ability to protect and assert the rights of vulnerable individuals against abusive practices.

I could not have asked for richer experience this summer. As I begin my legal career I will look back on my work with ALAS as having provided the foundation for a life-long dedication to protecting the rights of the less powerful. I would like to thank Equal Justice America for enabling me to embark on this journey.


As you know, Fuery Hocking was an Equal Justice America fellow in our office over the past summer. During that time, Fuery's contribution to our office was enormous.
