Summer Fellowship Experience

I am writing this letter to share my summer internship experience in Ayuda.

June 1, 2015 I have started my internship in Ayuda in Domestic Violence/ Family Law Unit. The first couple of days were training on the general activity of the organization and what services they provide. The training also includes the DC family law and domestic violence rules and internal work rules of the organization. It was very interesting as it helped me better understand the working environment and their area of work.

After I completed the training, I was assigned to work with the staff attorneys at the domestic violence/ family law unit. Working with the staff attorneys on different cases helped me to develop my legal writing and research skills especially on preparing court briefs, petitions, motions, and letter and discovery requests for CPO, child custody, child support and divorce cases. In addition I was also assigned to assist in different research projects.

I also prepared the Ethiopian Community Cultural Competency training material and delivered the training for all Ayuda DC and Virginia office employees on July 10th. This helps Ayuda's staff attorneys better serve Ethiopian survivors of domestic violence. I was very excited about the training and worked hard to produce a training material that outlives the training.

Besides, I also worked as an Amharic language interpreter for Amharic speaking clients for screening, intake and attorney-client supervision. Working as an intern in Ayuda also helps me to often go to Superior Court of the District of Columbia Family Court in order to file

petitions and motions for CPO and family cases and accompany clients for their hearing. This gives me the opportunity to better understand how the U.S. justice system works on family and domestic violence cases.

I have worked with more than 13 clients who are immigrant women victims of intimate abuse. I assisted the clients on their civil protection order, divorce, child custody and child support and immigration cases. The services I provided include but not limited to filing petitions and motions for CPO, family cases and immigration cases and accompany clients to court for their hearing. Working with all my clients and help them get protection was a great success to me. Interning in Ayuda this summer gave me the opportunity to serve vulnerable, low-income immigrants who seek to better their lives. And that was the biggest achievement in my career.

All the staffs at Ayuda were very positive and willing to assist with everything. It is a very professional work environment and the attorneys at the Domestic Violence/ Family Law Unit gave me very positive and helpful feedbacks on my work.

My weekly supervision meeting with the supervising attorney allows me to ask detailed questions and I was also able to get a great supervision and training on the cases that I have worked.

The experience I got from my internship in Ayuda surpassed my expectations. It also gave me a great experience and exposure that will allow me to pursue my career in public interest law and in the protection and promotion of women right.
