Dan Ruben Executive Director, Equal Justice America RE: Letter on Summer Fellowship Experience

Mr. Ruben,

My summer experience working at the Central Virginia Legal Aid Society (CVLAS) in Petersburg was excellent. The employees and clients that I worked with taught me many valuable lessons about the law and the people in our community. Although our clients have many of the same legal problems as people with greater incomes, they lack the ability to pay for the same legal representation and advice. The services provided by the CVLAS empower countless members of our community, and it was truly an honor to help represent these clients.

Among other issues, the CVLAS assists clients with Protective Order cases and the divorce, child support, spousal support, and child custody issues that stem from these cases. Within my first week at the CVLAS, I was surprised at the frequency of these cases. I began to realize that it was sometimes shockingly difficult to obtain a permanent Protective Order for our clients.

This fact became very clear to me during one of the Protective Order cases that I worked on this summer. For the purposes of this story, I will call the client Lily. On June 4, 2016, Lily and her boyfriend of one month were moving into a house together. Lily was excited about the new relationship until things took a turn for the worse that night. Lily was physically assaulted by her boyfriend and was terrified. She suffered from depression, anxiety, and PTSD, and all of these conditions worsened after the attack. On June 8, 2016, Lily courageously went to the police to obtain an Emergency Protective Order (EPO) and to press charges against her boyfriend.

The permanent Protective Order hearing was set for June 24, 2016, and Lily was incredibly nervous. This was the first time that she would see her attacker since she obtained the EPO. During the trial, Lily and two of her friends testified on her behalf. Her attacker did not testify, but a friend and some family members did. Despite Lily's testimony and pictures of her injuries, the judge denied Lily's request for a Protective Order because he found the fact that she waited four days to report her attack suspicious. Lily was distraught and terrified that her attacker could potentially harm her again.

Lily made a timely appeal to the Circuit Court and a new hearing was scheduled for August 3, 2016. I was hopeful that a new judge would understand that every victim reacts differently to abuse. This judge found that an incident of family abuse had occurred but did not see a need for Lily to have a permanent Protective Order against her aggressor. Lily was denied legal protection, and the fact that this judge

merely believed her testimony and pictures provided little comfort. Lily's financial situation did not cause the domestic abuse that she experienced, but it affected her ability to hire a civil attorney to help her. The CVLAS provides civil legal aid to individuals like Lily, free of charge.

Before I worked at the Central Virginia Legal Aid Society this summer, I was naïve about the number of individuals that needed our assistance. Many of these individuals are taken advantage of by individuals with access to money and legal resources. These power inequalities leave many individuals in our community homeless, in large amounts of debt, or without the protection of Protection Orders. I am incredibly thankful to Equal Justice America for providing me with the financial support to have the opportunity to work with, help, and learn from these clients.
